Seven (7) nights lodging in classic non course view twin rooms at the **MacDonalld Rusacks Hotel**. **Rusacks Hotel** is a lovingly restored Victorian edifice that sits beside the 18th fairway of the Old Course, the best lodging location in St. Andrews. The restaurant, which overlooks the R&A clubhouse, the first tee and the 18th green, is one of the best spots anywhere for golfer watching.

- Full breakfast each morning in your hotel.
- One (1) table d’hôte dinner at Rusacks.

Golf Courses:

- Greens fees for five (5) rounds of golf as follows:

Lundin Links Golf Club. Lundin was founded in 1868 and was played over what is known today as The Old Course, a composition of the seaward holes of both Lundin and Leven Links. In 1909, James Braid designed a new course from the original seaside holes and the area acquired away from the coast. A few modifications to the original layout have been made over the years although the character and splendour of Braid's original design is still very much in force. Lundin has hosted Open qualifying on many occasions, in addition to countless regional and national events.



Panmure Golf Club. Despite its short length, the course demands so much accuracy that it is a fitting challenge even to world class golfers. When Panmure served as the final Open qualifier for Carnoustie in 2007, it was the 7th time the course was so honoured.

Crail Golf Club - Balcomie Links. The Balcomie Links is a quirky Old Tom Morris design that hosts a club claiming to be 17th oldest golfing society in the world. The Links are true seaside links and provide excellent views of the North Sea. Crail is a must for golfers wishing to become immersed in the origins of the game.



New Course at St. Andrews. The New Course is a mere century old and, though not as inscrutable as the Old Course, is a good solid course in its own right. This Old Tom Morris design suffers from proximity to the Old Course. It is certainly more straightforward with an excellent collection of four pars. In fact, Golf Digest finds it to be one of the 100 top courses in the world outside the US.

Old Course at St. Andrews. Golf has been played here for half a millennium, and quirky and eccentric as it may be, the nervous thrill of playing away on the first hole, driving over the railroad shed on the diabolical 17th, or putting out of the Valley of Sin on the 18th green (with half the town looking on), is one of golf's great experiences.

- Privately guided walking tour of the “auld grey toon”, **St. Andrews.** Long before it became the Home of Golf, the town was the ecclesiastical centre of Scotland and home the Britain's third oldest university. The tour includes the castle, cathedral and university.
